Sir,

In producing herewith one accused person namely Kisan Roy (30yrs) S/o. Sota Roy of Farabari Balarampara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 08(Eight) Bottles of 60 Up Himalayan Gold Country Sprit each bottle containing 600 ML.
2. 06(six) Bottles of Kingfisher strong Premium beer each bottles containing 650 ML.

1. SI. Phup Rinchey Bhutia of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 01.07.2022 at 06:15hrs received a source information from Farabari, Balarampara that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 07 dated 01.07.22. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) ASI. Uday Sankar Bhattacharjee (2) C/393 Shyamal Ch. Roy (3) NVF-68 Amit Roy all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Farabari, Balarampara to work out the information. At 06:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Farabari, Balarampara and recovered the above noted articles from the possession of accused person namely Kisan Roy (30yrs) S/o. Sota Roy of Farabari Balarampara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ajit Majumder of Ambari-Falakata, PO. Kamarvita PS. NJP, Dist-Jalpaiguri and 2) Pritam Shekher Das S/o. Lt. Gautam Das of Mahamaya Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 07:05 hrs to 07:25 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Kisan Roy (30yrs) S/o. Sota Roy of Farabari Balarampara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
