With due respect, I am producing herewith one arrested accused person namely Subal Roy (27) S/O Chitto Roy of Sahudangi, Telanipara, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

3. 02 (two) bottle of McDowell's Rum (each containing 180 ml, total 360 ml)


I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 02.07.2022 at 16.05 hrs I received a secret source information that one person namely Subal Roy (27) S/O Chitto Roy of Sahudangi, Telanipara, P.S- NJP, Dist. - Jalpaiguri is selling ID liquor illegally at his shop at Haripur, Nichpara under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 83 dated 02.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Yadav all of NJP PS, SPC left for Fulbari Border Line PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 16.45 hrs we arrived at Haripur, Nichpara and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 17.05 hrs to 17.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Subal Roy (27) S/O Chitto Roy of Sahudangi, Telanipara, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
