NJP, Dist. - Jalpaiguri is selling ID liquor illegally at his shop at Haripur, Nichpara under New Jalpaiguri PS, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 83 dated 02.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam , CV/306 Biswajit Roy and CV/824 Niru Yadav all of NJP PS, SPC left for Fulbari Border Line PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 16.45 hrs we arrived at Haripur, Nichpara and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & scizare was made in between 17.05 hrs to 17.15 hrs.
