With due respect, I am producing herewith one arrested accused person namely Chinmay Madak s/o Prafulla Madak of Ghargaria, PS- Alipurdwar, Dist.-Alipurdwar A/P Tinbatti More, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

 21 (Twently One) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.).

1, PSI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 06.07.2022 at 1935 hrs I received a secret source information that one person namely Chinmay Madak s/o Prafulla Madak of Ghargaria, PS- Alipurdwar, Dist.- Alipurdwar A/P Tinbatti More, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel at Tinbatti More, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 301 dated 06.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, Cv/116 Rohit Mahato all of NJP PS, SPC left for Tinbatti More, PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1945 hrs hrs we arrived at Fulbari Bypass, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1955 hrs to 2015 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Chinmay Madak s/o Prafulla Madak of Ghargaria, PS- Alipurdwar, Dist.- Alipurdwar A/P Tinbatti More, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
