(ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I).

I, ASI Surojit Mallick of Panitanki TOP under Siliguri PS do herby lodge a written complaint against the above noted accused person to the effect that today on 07/07/2022 at 18:45 hrs I received secret source information that, one person is selling huge quantity of country spirit at Bidhan Market near Auto Stand under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with C/114 Naresh Hasda and C/984 Subhasish Das left for PO to work out the information. On search I recovered (i) 10(Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each. (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I).

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each. (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No-(I) under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 19:15 hrs to 19:45 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1200/-
