With due respect I MD Eshan S/O MD Lal of Vivekananda Nagar, Koila Dipu Ward No-7 would like to draw your kind attention to the following effect that Today at about 9.30 am the aforesaid person forcibly entered into our house with hockey stick, botam, lathi, Iron Rode, stone, Bricks with intend to kill us on a violent mood and mercilessly beaten us as a result my wife namely Sabina Khatoon sustained grievous hurt on upon her chest to caught her breast and also MD Ladla entered her in bathroom forcibly and open her wearing apparels and tried to push his penis in her vagina by keeping the same on her vagina at that time I tried to rescued her but the aforesaid persons caught me and mercilessly beaten me with the bottom, lathi etc and also torn my t- shirt and the aforesaid persons tried to kill my mother-in-law namely Nazra Khatoon agred about 62 yeras with the iron rode on her head and that time time MD Anwar tried to safe my mother-in-law but that time the aforesaid persons became more violent and they conjointly hatched up a deep rooted conspiracy to kill him and attacked him with sharp cutting weapons injury and blood is oozing from the injury presently aforesaid three persons namely Sabina Khatoon, Nazra Khatoon and MD Anwar are fighting for their life at Siliguri Hospital and finding no other alternative at that MD Anwar called police and police also came there then the aforesaid persons fled from there but they also threatening us with dire consequences by saying that "Aaj tumlog bach gaye lekin dusri baar tum logo ka lash v nahi milega". The aforesaid persons are very dangerous also involved in illegal work. Actually two son of my father-in-law purposefully created the aforesaid violence since very long time with the help of aforesaid persons wherein including themselves to grab the entire landed property of my father - in-law and prior to this aforesaid incident the aforesaid persons also assaulted us in various manner but due to public disgrace we are not lodged any complain before the police station considering that after lapse of time everything will be okay but today they cross their limit if today I were not there then they will murder my wife after committing rape. The aforesaid persons also snatched the nose pin of Guriya Khatoon and one gold chain of MD Anwar approx 14 to 15 gram. And the aforesaid persons also committed the offence of outrage the modesty of women by touching their private parts and torning their wearing apparels and they also pelted stones, bricks upon them.

In view of above you are requested to book the aforesaid culprit immediately and punish them according to law for committing the offence of physical assault( grievous in nature by disfiguration of face of MD Anwar), stolen the nose pin and gold chain, attempt to murder and rape and also outrage the modesty of women.
