Respected Sir,

I, Sayed Arif Ali @ Kochi, Son of Sayed Amin Ali, resident of Ashraf Nagar, Ward No. 40, P.O. Haider Para, P.S. Bhakti Nagar, Dist-Jalpaiguri, would like to report you the following facts:-

- 1. That one Adil Ahmed, Son of not known is my neighbor who live in the same tenanted house.
- 2. That since long said Adil Ahmed and his wife Khalida Razia has been torturing us both physically and mentally. Said Adil Ahmad is an Addict and he remains in contact anti-social persons and he is very dangerous and desperate in nature and many times he had brought goons into our house for threatening us. They pick up quarrel with us without any reason and they have assaulted me and my wife several times earlier by fits and blows and even bitten my wife on her shoulder and for which my wife lodged complaint against them at your P.S, and specific case was started against them.
- 3. That yesterday i.e. On 06.7.2022 at about 8:30 p.m. again said Adil Ahmed and his wife forcefully entered into our room and started threatening us and abusing us in filthy language and pressurize us to withdraw the complaint lodged by my wife but I flatly denied to do so

then they started assaulting us by fists and blows and by kicks and they both tore the wearing apparels of my wife and badly touched her body part and threatened that if we do not listen to them they would murder us by hiring Gundas and he told that as earlier again he will bring more hire goons and this time he would definitely murder us and no one can save me from his hands wherever I go and ransacked all my house took snatched the finger ring made of gold from my the hands of my wife and cash Rs.5350/-from my pocket and threatened that next time we will have to face more dire consequences for not withdrawing the complaint and went away from there.

- 4. That due to such assault my wife received injury in her chest and abdomen and was not able to sleep whole night due to pain so I took her at Siliguri S.D. Hospital in the morning on 07.7.22 and she was treated there.
- 5. That the incident took place at night and we could not go at P.S. for lodging F.I.R. leaving our minor children at home and my wife was under severe pain and no one was there to look after her and I was in fear that in my absence at night said Adil Ahmad could do something to my wife so delay is caused lodging this FIR.

I, therefore, request you to kindly take necessary legal action against said Adil Ahmad for the commission of aforesaid offences.
