This is to inform you, I Hitesh Jain S/O Ravindra Kumar Jain R/O Kamla Niwas.Opp Syndicate Bank.SF Road,Siliguri and I am to lodge this complaint on behalf of my father i.e Ravindra Kumar Jain, S/O Late Nemchand Jain am a resident of Kamla Niwas, opposite Syndicate Bank, S.F. Road, P.O and P.S – Siliguri, Dist.- Darjeeling. That my father had been to The Four Vedas, Matigara situated on Khaprail Road to attend a wedding ceremony on the 6th of July, 2022. That while my father was on his way out at around 11 P.M from the said wedding ceremony, Dhiraj Ghosh, S/O Late Dharendra Nath Ghosh, resident of Gossainpur, near Uttora, Bagdogra, P.O and P.S – Bagdogra, Dist.- Darjeeling pushed my father without any instigation whatsoever. That upon my father's protest he started verbally abusing him with extremely vulgar and filthy slang languages. That the said Dhiraj Ghosh then further went on to vehemently physically assault my father with slaps, blows and kicks to which my father sustained grevious injury and threatened him with life while doing so. Thereafter, my father was rescued with some local interference from the people around. That the said Dhiraj Ghosh is an extremely influential and connected person and has ties with anti-social miscreants and lawbreakers. That due to the abovementioned activities and situation, my father is presently under great stress and trauma and have been treated by doctor and is in no situation so lodge this complain before you *and he is presently in Nepal to attend the death ceremony.*

Hence I pray before your good self to kindly look into the abovementioned matter and after proper investigation take necessary action against the said Dhiraj Ghosh for the ends of justice.
