That I had lodged a written complaint against one Vishal Kumar with your Police Station alleging that he has committed rape on me and such diary give rise to Siliguri Women Cell, Vide, P.S. Case 18/2022 corresponding to G.R. Case No.808/2022, U/s.376/417/420/506 IPC.

Vishal Kumar applied for and was granted anticipatory bail by the Ld. Sessions Judge. Darjeeling on 23/03/2022. Since then I have been receiving threat messages which I have already submitted with you.
