Respected Sir,

With due respect, I, **SRI UDAY YADAV**, Son of Late Jagdish Yadav, Resident of New Pokaijote, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to lodge this written complaint before your good office to the effect that I have been working as an employee of M/S G.D. in Stall No. 6 of Regulated Market since long. Sir, as the Regulated Market is remains close on every Sunday, I along with other laborers including my brother Dharmender Kumar who are engaged in different Stalls of the Regulated Market, were gossiping with each other in front of Stall No. R.K. TC-2 of Regulated Market. Sir, today i.e. on 10.07.2022 at about 1.30 P.M. to 1.45 P.M., when we were gossiping with each other, one **Shiv Narayan Yadav @ Bantha** who is also working in the Stall No. 1/3, B.P.S. of Regulated Market came in front of us with fully drunken condition and started to throw some abusive and slang languages towards us and when we requested him as to why he is behaving in such a manner, he left the place and immediately after 15 minutes, said **Shiv Narayan Yadav @ Bantha** along with his engaged persons namely (1) **Mahesh Yadav**, Son of Late Jiwach Yadav, (2) **Umesh Sahani**, Son of Late Rajender Sahani, (3) **Umesh Yadav**, Son of Late Jiwach Yadav, (4) **Uma Shankar Yadav**, Son of Kailash Yadav, (5) **Makeshwar Yadav**, Son of Late Khatrar Yadav, (6) **Ajit Mandal**, Son of Kishori Mandal, (7) **Arun Mandal**, Son of Late Okil Mandal, (8) **Sakhichand Yadav**, Son of Late Shibjit Yadav, (9) **Shambhu Paswan**, Son of Ram Madhin Paswan, (10) **Binod Yadav**, Son of Sri Lilo Yadav, (11) **Lalan Sahani**, Son of Late Satto Sahani, (12) **Sarbhan Sah**, Son of Bindeswar Sah, (13) **Ram Udgar Paswan**, Son of Fuleswar Paswan, (14) **Indrakant Yadav @ Indal**, Son of Kailash Yadav, (15) **Harsh Yadav**, Son of Uma Shankar Yadav, (16) **Ugan Yadav**, Son of Kailash Yadav, (17) **Ram Kumar Yadav**, Son of Tumu Yadav, (18) **Laltu Yadav**, Son of Ram

Kumar Yadav and others have come in front of Stall No. R.K. TC-2 of Regulated Market, where we are standing and gossiping and suddenly attacked upon us with Sharp Cutting Iron Hook, Iron Rod and other dangerous weapons with an intention to kill us and due to their said attacked and assault, my brother **DHARMENDER KUMAR**, Son of Late Jagdish Yadav has received severe blood injury on his head and other persons also received injuries on their persons. The miscreants attacked upon my brother and others with an intention to kill us in a preplanned manner and the miscreants also possessed Arms and Ammunition and by showing the said Arms and Ammunition, they have attacked upon my brother and others and seeing the said situation, one of the Pedestrian informed the Officer of Pradhan Nagar Police Station as the Pradhan Nagar Police Station is situated nearby to the said place of occurrence and receiving the said information, the police personnel of Pradhan Nagar P.S. reached there and rescued my brother and ourselves from the hands of the miscreants above named. Thereafter, with the help of the Pradhan Nagar Police, my brother brought at Siliguri District Hospital for treatment and considering the severe injuries on his head, he has been admitted and still now, his condition is critical and he is struggling with life and death at Siliguri District Hospital.

I, therefore, request you to investigate into the matter and please take appropriate strong legal actions against miscreants above named who are behind this crime as per the provision of law and obliged thereby.
