Sir,

I, ASI Dipak Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate, do hereby lodged this written complaint against one Madan Limbu (52 yrs) S/o Lt. Iman Limbu of Chota Fhapri, Near Tiger Yuba Sangha, PS-Bhaktinagar, Dist. Jalpaiguri under arrest along with following seized articles:-

1. 12 (Twelve) bottles of Kingfisher strong beer (each bottle containing 650 ml)
2. 06 (Six) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml)

In this regard, I ASI Dipak Karmakar of Bhakti Nagar PS, Siliguri Police Commissionerate beg to report that today on 10/07/22 at about 20.30 hrs. myself along with force were engaged on mobile van duty at P area and received information that one person who carrying huge illicit liquor near Mandal Petrol pump Eastern Bypass under Bhakti Nagar PS for selling to the local customers for illegal gain. This refers to Bhaktinagar PS GDE No. 505 dated. 10/07/22. As soon as after receiving the information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid near Mandal Petrol pump Eastern Bypass under Bhakti Nagar PS and apprehended one person namely Madan Limbu (52 yrs) S/o Iman Limbu of Chota Fhapri, Near Tiger Yuba Sangha, PS-Bhaktinagar, Dist. Jalpaiguri and seized the above noted articles from his possession. During raid I found that the above noted arrested accused is possessing the above noted articles for selling it to the local customers for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses, I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. During interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and selling the same illegally to the local people since long. Accordingly, I seized the same after preparing proper seizure list duly signed by the witnesses and accused. Then, I arrested him U/S 41 Cr.P.C. The arrest was seized in between 21.20 hrs to 21.50 hrs.

Therefore I pray before your honour that a specific case may kindly be started against one namely Madan Limbu (52 yrs) S/o Lt. Iman Limbu of Chota Fhapri, Near Tiger Yuba Sangha, PS-Bhaktinagar Dist. Jalpaiguri as per proper section of law.
