I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, would Like to lodge a complaint against {Sri Rabindra Nath Saha (ph no- 9093189121), Son Of Late Dinesh Chandra Saha & his sons}, {Sri Bhola Choudhury (ph no-9832018790) & his son Sri Sanjeet Kumar Choudhury} & Sri Babu Sheik Of Lower Bhanunagar area, opposite Modak sweet shop, P.S Bhaktinagar, Dist Jalpaiguri.

For the past few days we are receiving complaints about frequent power failure, and conductor snapping in the above mentioned area. These issues of power failures are not only hampering the lives of general public and consumers of WBSEDCL in the area but also hampering the reputation of WBSEDCL, While on the other hand, the more important part is that naked con luctors of this particular transformer are snapping continuously almost every day due to heavy summer loading in the area which is certainly a heavy risk as this might cause fatal accidents. To resolve these issues WBSFDCL personnel (Sri Baliram Oraon – ACM, Sri Chandan Chakraborty – Agency worker and others) tried to augment our L.T infrastructure and install an 8 meter PCC pole so that the load of the Transformer could be reduced by sharing the load with another transformer, and after surveying the line it was found that this was the only place and option by which resolution of the above problems could be attained. As a result of that we were executing a work related to installation of a 8 meter PCC pole to resolve the issue on 10.07.2022, our personnel reached the site at around 10.30am . The pole was to be installed on the land, not owned by any of the above mentioned parties and is the land in front of their property for public use road, just like almost every other installations of WBSEDCL. But at the moment of execution of work Sri Rabindra Nath Saha, Son Of Late Dinesh Chandra Saha & his sons And Sri Bhola Choudhury & his son Sri Sanjeet Kumar Choudhury, Sri Babu Sheik and other local people started creating ruckus, hurdling foul & abusive language to the personnel of WBSEDCL, while objecting and obstructing Government work that was being done for the greater benefit of general public. The total reason as to why the work was important to be executed was continuously explained to all the mentioned parties repeatedly but they refused to understand and did not let us work, without any specific reason from their side. Our personnel left the site at around 1.00pm.

These un lawf il activity with malafied intensions by Sri Rabindra Nath Saha, Son Of Late Dinesh Chandra Saha & his sons And Sri Bhola Choudhury & his son Sri Sanjeet Kumar Choudhury & Sri Babu Sheik , not only denies proper access of basic rights of the general public, but also puts the lives of common people in danger in case of any accident occurs due to snapping of conductor, fire hazard or faults due to overloading of the conductors from that particular transformer by obstructing a public servant from delivering his duties, the transformer is located in front of Gupta Ji building in that area, with the LT network ending in front of the premises of Sri Sri Rabindra Nath Saha.

Thus you are requested to kindly initiate an investigation and take necessary against Sri Rabindra Nath Saha, Son Of Late Dinesh Chandra Saha & his sons And Sri Sanjeet Kumar Coudhury, Son Of Sri Bhola Choudhury.

It would also be a request from our side that you provide additional force for the execution of the work, and intimate us about the time when we shall arrange to re execute the work in presence of the additional force.
