Respected Sir / Madam,

I, Mrs. Neha Sah, Wife of Mr, Sashi Sah, Daughter of Ram Kumar Shah, resident of Iskcon Road, beside Ganesh Bhawan, P.S. Bhaktinagar, Dist - Jalpaiguri would like to bring to your information that I got married to Mr. Sashi Sah as per Hindu rites and customs on 30th November, 2013. In the beginning everything went fine along with me, my husband namely Sashi Sah and my in-laws which was depicted by their pleasant behaviour towards me. Soon after the married their attitude towards me altered drastically. They were treating me like trash and torturing me for dowry. They had already taken cash of Rs. 15 lakhs as wells as 400 grams of gold and other household materials from us. Inspite of providing them with the above demands, they don't get satisfied. My sister-in-laws namely, Sunita, Pinky, Ruby and Sangita and Sony sah my niece along with my mother-in-law namely Sushila Devi and my father-in-law namely Jagadish Prasad inflicted mental and physical torture on me for fulfilling their demands to the extent that they even put kerosene oil with the intention of harming me. Meanwhile, I got pregnant. Unfortunately they didn't want me to have baby which was clearly depicted by their misdeeds. They attacked and hit me, as a result it led to miscarriage and then they did separation and send me to siliguri. My father-in-law Jagadish Prasad, sister in-law Sunita w/O of Roshan Sha of Jaigaon P.S. Jaigaon, dist. Jalpaiguri, Pinky Sha, W/O Akash Kumar Siwan Bihar is the main conspirator. In 2017, 2018 and 2019, I got pregnant again but they were dissatisfied with the pregnancy news. They kept giving me medicines in the form of pills due to which I suffered from miscarriage again and again. The reason they didn't want any baby was related to share in property. My in-laws always wanted my husband to marry again with a girl from Bihar and even forced him to take such steps. My husband has no emotional feeling towards me. He only used me for physical relations to satisfy himself. As a result, I got pregnant again and this time in order to protect my baby, I went to my father's house so that safe delivery of child can be ensured.

After 8 months, I visited the house of my in - laws again and on December 2021 my father - in - law attempted to murder me by pressing pillow against my face and another five persons namely Jagadish Prased @ shah, Sushila Devi, Soni Sah, Sunita Sah, Ruby Sha , Pinky Sah were holding my legs and hands so that I could not evade or rather escape. Somehow I managed to save my life and flee from that place. Finally, I delivered my first child on 17th December, 2021. Eventually my husband's addition increased so he was sent to rehabilitation. Meanwhile I discovered that my husband had an extra marital affair with a girl name Pooja and to my astonishment my in- laws totally supported this affair and in fact wanted my husband to marry that girl. My in - laws always wanted to get rid of me and my child and took several steps to harm us. They even took custody of my gold ornaments and other materials and denied to give them to me .

Due to the prevailing circumstances, I am at great unrest. My husband, father -in -law as well as sister - in - laws since then has repeatedly been inflicting torture on me and has been harming me and my child. In between this period they did so many mutual sitting and agreement . I did not complain because I did not want to spoil my married life and defame my in - laws and relatives and could not move to court as because of my small baby .

Therefore , I request you to look into this matter, immediately take steps as soon as possible and assist me out of this problem by taking stringent action so that I can take a sign of relief. I will be extremely grateful if you take necessary measures for the ends of justice.
