I, Sri Sandeep Agarwal, son of Shri Chhabil Dass Agarwal, one of the Director of 'Era Construction Private Ltd.', resident of Premangan, Panchvati Housing Complex, Sevoke Road, Jyoti Nagar, Ward No. 41 of Siliguri Municipal Corporation, P.O. Sevoke Road and P.S. Bhaktinagar, Dist-Jalpaiguri, West Bengal-734001 would like to inform you as follows:

- 1. That on 29.10.2018, 'Era Construction Private Ltd.' (a company registered under Companies Act, 1956) having its office at 1st Floor Moti Sadan, Opp. L.I.C. Building, Sevoke Road, Siliguri, P.O. & P.S.
