That since after marriage, her husband with his family members started abusing my daughter and torturing her physically and mentally for demanding dowry i.e. Maruti Car, Cash, Jewellery, Gold & Silver ornaments etc. Then in the month of May, 2022 my daughter's husband with his family members again started torturing my daughter for the same reason and we went to my daughter's house for settlement and they settled with each other.

On 11/07/2022 at about 8:30 p.m. me, my husband, my son namely Rabi Barman, with another family members went to my daughter's house for solving her marital problem between her and her husband and her in-laws but without listening us my son-in-law with his family members started beat my daughter by wooden batam with intention to kill and also by holding her hairs. Then my daughter became senseless and when we protest then my son-in-law and his family members also beat us roughly and also tried to stuck us in a room but they failed. Then we took our daughter to the Siliguri District Hospital in my vehicle at about 10:00 p.m. and then we admitted her to the hospital. Now she is in very crucial situation.
