Sir,

With due respect I, Smt. Sunita Chowdhury W/o Sri Manish Chowdhury D/o Sri Raj Kumar Chowdhury residing at Shantipara, Near Kalimpong House, P.O - Salugara, P.S -Bhaktinagar, District – Jalpaiguri, would like to state that on 12 – 12 – 2018 my marriage was solominized with one Sri Manish Chowdhury S/o Sri Manoj Chowdhury of 166/5 Ward No – 3, Pana Colony, Meharauli P.O & P.S – Meharauli, Dist – South Delhi, 110030 at my parental house at Shantipara, Near Kalimpong House, P.O - Salugara, P.S - Bhaktinagar, District - Jalpaiguri, according to Hindu rites and customs and after marriage I was taken to my matrimonial house and has started leading my marital life with my husband and in laws. At the time of marriage, as per demand of my husband and his mother Smt. Pushpa Chowdhury my parents have paid a sum of Rs. 5,00,000/- which consists the cost of household articles, Bike, Cooler Machine, Freeze, and other furniture and out of the said money they will be entitled to keep a sum of Rs. 2,00,001/- towards cash dowry and my parents have also gave me 3 numbers of Gold finger ring, Neckless,, Mangtika, Nathiya, ear tops (Gold) and Payal, Tora chain (Silver) to me towards stridhan property. Soon after marriage. I noticed that my husband is leady crazy man having affairs of several ladies and when I have put my objection before my Mother - In - Law Smt. Pushpa Chowdhury, my sister in - law Smt. Priyanka Chowdhury W/o Sri Sanjiv Chowdhury who is permanently residing at my matrimonial house after deserting her husband and Sister in law Smt. Puja Chowdhury /o Sri Gopal Chowdhury resident of who is the resident of Bindole, Raigani, Uttar Dinalpur and all the above three persons have told that they are aware about the fact and to make him control, they have arranged marriage with me and now it is my duty to control him. Be it mention here that when ever I tried to raise my objection before my husband Manish Chowdhury, he used to say that the ladies with whom he has the relation, they have the capacity to purchase me and have started mental am physical torture upon. In the mean time I became pregnant, and on 23 - 3 - 2019 my husband brought me to my parental house on the eve of Holi. After coming here, my husband has started demanding money amounting to Rs. 5,00,000/- to start his own business to keep me happy and when my parents denied on the pleading of their capacity, he became furious and in presence of my parents during my pregnancy, has mercilessly assaulted me and fled away alone.

After the said incident, on several occasions I have asked and requested my husband and inlaws as above named to take me back but they have flatly denied for the same and asked me to come alone finding no other alternative in the month of may I had been to my

matrimonial house and after seeing me the above named persons have started teasing me that I have / had no way but to obey their orders and direction. On 27 - 10 - 2019 I have delivered a male child namely Ravish Chowdhury at Safdarganj Hospital but it is very unfortunate to say that after discharge from hospital, inspite of having the knowledge that I am Ill but they neither provided me adequate food nor they have given me proper treatment causing when my health has started detiorating day by day I called my mother to take me back and lastly on after nineteen days of delivery, I returned back to Siliguri with my mother. Even after my return, my husband and other in laws have started teasing that my parents will not up-bring me for all time and I have to return back. After considerable time when I noticed that neither my in-laws nor my husband is showing any interest to take me back, ultimately as per direction of my mother in law on 27 - 10 - 2020 I had once again alone with my breast sucking baby had been to my matrimonial house. It is to be submitted here that after my arrival at my matrimonial house, the behaviour of my husband and other family members have totally changed and off and on my husband has started assaulting me with threatening to divorce me. In the night of 27 - 5 - 2021 my husband, mother -n - lawand sister - in law namely Priyanka Chowdhury have assaulted me mercilessly though my father in law tried to save me but they have threatened him that they will oust him alongwith me from the house and when the mental and physical torture from their end became unbearable, I have called my mother in and ultimately on 4-6-2021 I came to my parental house to save my life. My husband is Jim trainer and running his own institute of Jim and dance academy at Meharauli. On several occasions, I have asked and requested my husband and other in laws to take me back but they have denied for the same. My husband is neither paying any money nor taking any interest in me. I have tolerated all the tortures with the hope that my husband and in-laws will rectify themselves but all are in vain. Still my husband is threatening me over phone that if I dare to visit Delhi, he will kill me and if I dare to make any compliant, he will divorce me.

So requesting you to investigate the matter and take necessary legal actions against the above named persons for the interest of justice.
