1. Fifteen (15)Bottles Country Spirit styled as Himalavan Gold 60 UP of 600 ml each, MRP Rs.

2. One(01) Nylon Bag which used for carrying the seized articles SL. No. 1

I. ASI Biswajit Saha of Panitanki TOP under Siliguri PS herby lodge a written complaint against the above noted accused person to the effect that on 17.07.2022 at 17.05 hrs received one secret source information to the effect that one person is carrying huge quantity of bottled country spirit through Sevoke Road towards Janata Nagar, Siliguri. Accordingly the information was diarized vide Panitanki TOP GDE No. 388 dated-17.07.2022 and informed to O.C., Panitanki TOP and thereafter as per his instruction I along with, ASI Surojit Mallick, ASI Mantu Dey, C/984 Subhasish Das C/370 Bharat Ch. Roy, C/999 Mithu Ch. Roy, C/499 Narendra Nath Barman, CV-1007 Jiten Roy left from Panitanki TOP to work out the information. On arrival infront of Sevoke Road Post Office Siliguri at 17.25 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses namely (1) Subodh Kumar, s/o Dipok Mahato of village-Mandaidi. PO- Mahua, Dist- Baishali, (Bihar) A/P Durga Nagar, Isckon Road, w/n-40, PS-Bhaktinagar, Dist- Jalpaiguri. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Vidya Chakra Colony adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized Fifteen (15)Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/-and 2) Two Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labelled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 17.45 hrs. to 18.15hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, ander the above noted circumstances I am submitting this written complaint against the above accessed person namely Khokon Roy(M/27), s/o Lt Rathindra Nath Roy of Vidya Chakra Colony, Ashighat Road, w/n-44, PS-Bhaktinagar, Dist-Jalpaiguri for starting a specific case under
