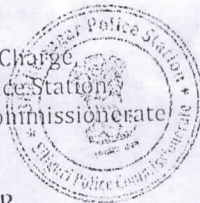

Subject: - F.I.R

Sir,

In producing herewith the seized 10 (Ten) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total-6 Liter & Amount Rs 1200/-) and lodged a written complaint against the lady accused person namely Smt Budhuni Ashur (66) W/O Late Budhua Ashur of Fakdaibari Radha Gobinda bazar PS Bhaktinagar Dist Jalpaiguri.

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person Smt Budhuni Ashur (66) W/O Late Budhua Ashur of Fakdaibari Radha Gobinda bazar PS Bhaktinagar Dist Jalpaiguri to the effect that, today i.e 20.07.2022 evening as per order of O/C Ashighar OP I along with SI Swapan Kr Ghosh C/877 Munna Ahmed, L/C 497 Jharna Roy and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 496 Dt 20.07.2022 in course of which I received information from my source that one Smt Budhuni Ashur stored a huge numbers of bottles liquor inside her house at Fakdaibari Radha Gobinda bazar and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Fakdaibari Radha Gobinda bazar area to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kali Charan Das of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Fakdaibari Radha Gobinda bazar area as indicated by my source I held raid at the house of Smt Budhuni Ashur at Fakdaibari Radha Gobinda bazar. But the lady accused person managed to escape from the spot. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as none could be able to produce any documents for such illegal possession of such articles. During enquiry I came to know the name and address of lady accused person is noted above. The Search and seizure were made in between 17.15 hrs and 17.35 hrs on 20.07.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Smt Budhuni Ashur(66) W/O Late Budhua Ashur of Fakdaibari Radha Gobinda bazar PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
