With benign submission I, SI. Kankan Paul of presently posted at Siliguri Police Station, Siliguri Police Commissionerate under your kind disposal would like to lodge this written complaint against 1) Arijit Das of Siliguri, President of Bharitya Janata Yuba Morcha and 2) Bappi Paul, 3) Prasanjit Paul, 4) Ratan Sharma, 5) Anit Das of Siliguri along with other 25-30 unknown BJP supporters to the effect that on 23.07.22 I was deputed to perform CS - I evening mobile patrolling van duty at Siliguri Hill Cart Road area vide Siliguri PS MCC No. 1112/22 dated 23.07.22, while performing CS-I Mobile Van myself along with CV/ 523 Sevok Barman, CV/ 744 Goutam Singha that time at about 18.00 hrs received an information from Siliguri Control room that 25-30 BJP Supporter assemble at Venus more under PS Siliguri and started demonstrating over the issue of arrest Sri Partha Chattarjee Hon'ble Industrial Minister of West Bengal and during protest they try to burn his effigy. Accordingly myself along with force had been to Venus more and found the BJP Supporters blocked the Venus More area and also officer and force are present in the spot deployed from SPC Head Quarter, then I try to Make the supporters understand that due to their demonstration huge traffic congestion occurred in the busy hours and the public in general been suffered from this, they pay no heed to my wards and continue their program blocking the main road at Venus more from all side. When I along with force tried to clear the traffic then for smooth movement and tried to relief them on that time on that time 1) Arijit Das of Siliguri, President of Bharitya Janata Yuba Morcha and 2) Bappi Paul, 3) Prasanjit Paul, 4) Ratan Sharma, 5) Anit Das of Siliguri along with other 25-30 unknown BJP supporters restrained us by using criminal force and assaulted us and tried to deter us from public duty and also tried to burn a effigy in the middle road at Venus More which is such crowded in the rush hours by endangering the life of the common people. Due to the attack of the Police persons one ASI Santanu Sarkar of Head Quarter of Siliguri Police Commissionerate sustained injured and shifted to Siliguri District Hospital for his treatment with the help of the Police personnels deputed there, by taking this advantage the accused persons escaped from the place.

Therefore I pray before your kindness that a specific case under proper section law may kindly be started 1) Arijit Das of Siliguri, President of Bharitya Janata Yuba Morcha and 2) Bappi Paul, 3) Prasanjit Paul, 4) Ratan Sharma, 5) Anit Das of Siliguri along with other 25-30 unknown BJP supporters and arrange for it's proper investigation in the interest of justice.
