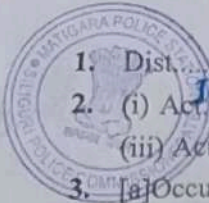

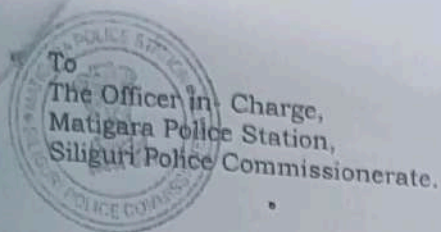

In producing herewith 06 (Six) arrested accused persons namely (1) Snehasish Chakraborty(55), S/O- Lt. Bishnupada Chakraborty of HIG A5/2, Himalayan Kanyas Abasan, 2nd Mile, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Anil Kumar Yadav(36), S/O- Karneswar Prasad Yadav of Khudnarupaspur, PS+ Dist- Katihar, State-Bihar, (3) Bikram Kishor (42), S/O- Lt. Braj Kishor Chowdhury of Flat-5, B1, Barsana, PO+PS- Matigara, Dist- Darjeeling, (4) Priya Das(20), D/O- Mahesh Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri, (5) Diya Das(20), D/O- Gouranga Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri and (6) Pinkey Barman(24), D/O- Raj Kanta Barman of Thakurnagar, BJP Para, PS- Bhaktinagar, Dist- Jalpaiguri along with following seized articles :

- (i) One trade licence having Form No. 11 Trade registration No 5144 dt. 11.07.2022 for the period 2022-2023, 2023-2024, 2024-2025 issued from Patharghata G.P., issue date- 14.07.2022 in respect of "CUTENESS UNISEX SALOON AND SPA" at City Centre, Matigara in the name of Riya Saha.
- (ii) One sealed packed Condom's marked as "MANForce" found into the drawer of a table kept inside the "CUTENESS UNISEX SALOON AND SPA".
- (iii) Three numbers of Condom which was lying on the bed of "CUTENESS UNISEX SALOON AND SPA".

I, Asish P. Subba, Assistant Commissioner of Police, Traffic, West Zone, Siliguri Police Commissionerate(holding additional Charge of ACP, West Zone, SPC), do hereby lodge this written complaint against the above noted 06(Six) arrested accused persons namely (1) Snehasish Chakraborty, (2) Anil Kumar Yadav, (3) Bikram Kishor, (4) Priya Das, (5) Diya Das and (6) Pinkey Barman to the effect that on 23.07.2022 at 14.15hrs received a specific secret information that some prostitution business is going on at "CUTENESS UNISEX SALOON AND SPA" at City Centre under Matigara PS, Dist- Darjeeling under the coverage of body massage. Accordingly, I along with force left for "CUTENESS UNISEX SALOON AND SPA" at City Centre under Matigara PS via Matigara P.S and obtained assistance of the police team from Matigara PS to verify the veracity of information. This refers to Matigara PS GDE No. 1730 Dated. 23.07.2022. SI Goutam Mallik, PSI Shekhar Adhikary, ASI Subodh Biswas, C/ 974 Mintu Sen, LC/1324 Lalita Singha and LC/1286 Anisha Chhetri all of Matigara PS, SPC accompanied us.

On arrival at "CUTENESS UNISEX SALOON AND SPA" at City Centre, under Matigara PS, I called two available local independent witnesses namely 1) Kiran Baraik, S/O- Surjan Baraik of Atal Tea Estate, Paka Line PS- Naxalbari, Dist- Darjeeling and 2) Mampi Sutradhar(Saha)(29), D/O- Nitai Sutradhar of Nasirhat, Hariharpur, PO- Dhankoil Hat, PS- Kalyagunj, Dist- Uttar Dinajpur, A/P- Shibmandir, NBU Gate-2, PO- Kadamtala, PS- Matigara, Dist- Darjeeling and requested them to remain present during the time of raid, search and seizure, if any. Subsequently, we entered into the shop styled as "CUTENESS UNISEX SALOON AND SPA" at City Centre ground floor along with the aforesaid witnesses and found the above noted male and female persons were in an objectionable position. The above noted Snehasish Chakraborty, Anil Kumar Yadav and Bikram Kishor were found naked and above noted Priya Das, Diya Das and Pinkey Barman were found wearing only underwear. It is reason to believe that they were involved in sexual activities.

Thereafter with the help of lady police we separated the female from the male persons. On being asked in presence of lady force, female persons disclosed their identity as (i) Priya Das(20), D/O- Mahesh Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri, (ii) Diya Das(20), D/O- Gouranga Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Pinkey Barman(24), D/O- Raj Kanta Barman of Thakurnagar, BJP Para, PS- Bhaktinagar, Dist- Jalpaiguri and further they disclosed that that they along with Riya Saha and others are operating this illegal business of prostitution.

On interrogation said male persons disclosed their identity as (1) Snehasish Chakraborty(55), S/O- Lt. Bishnupada Chakraborty of HIG A5/2, Himalayan Kannya Abasan, 2nd Mile, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Anil Kumar Yadav(36), S/O- Kameswar Prasad Yadav of Khudnarupaspur, PS+ Dist- Katihar, Bihar, (3) Bikram Kishor (42), S/O- Lt. Braj Kishor Chowdhury of Flat-5, B1, Barsana, PO+PS- Matigara, Dist- Darjeeling, and they also admitted that they came there for their sexual pleasure in lieu of paying money. They further disclosed that today they were informed at the reception of the "CUTENESS UNISEX SALOON AND SPA" that they give sexual pleasure for money and as they agreed to pay money, they were taken inside the room behind the counter, thereafter (1) Snehasish Chakraborty and Priya Das, (2) Anil Kumar Yadav and Diya Das and (3) Bikram Kishor and Pinkey Barman got engaged in sexual activities with them.

On further interrogation all of detained ladies namely Priya Das, Diya Das and Pinkey Barman stated that they in connivance with others are operating this business of illegal prostitution under the camouflage of body massage in a public place i.e. City Centre, Matigara for their wrongful monetary benefit. They also admitted that they meet up the urges for sexual pleasure of customers by demanding extra money and provide them sexual pleasure.


In course of further interrogation it is revealed that all of detained ladies namely Priya Das, Diya Das and Pinkey Barman are co-conspirer along with others in inducing persons to carry on prostitution under the veneer of ostensible lawful business activities.

Accordingly, we searched the "CUTENESS UNISEX SALOON AND SPA" in presence of independent witnesses and found above noted articles which had been seized under proper seizure list as noted above. Then, I arrested the above noted accused persons namely (1) Snehasish Chakraborty, (2) Anil Kumar Yadav, (3) Bikram Kishor, (4) Priya Das, (5) Diya Das and (6) Pinkey Barman and subsequently, I brought them to Matigara Police Station.

Hence, I would like to request you that a specific case under proper sections of law may please be started against accused persons namely (1) Snehasish Chakraborty(55), S/O- Lt. Bishnupada Chakraborty of HIG A5/2, Himalayan Kannya Abasan, 2nd Mile, PO- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Anil Kumar Yadav(36), S/O- Kameswar Prasad Yadav of Khudnarupaspur, PS+ Dist- Katihar, State-Bihar, (3) Bikram Kishor (42), S/O- Lt. Braj Kishor Chowdhury of Flat-5, B1, Barsana, PO+PS- Matigara, Dist- Darjeeling, (4) Priya Das(20), D/O- Mahesh Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri, (5) Diya Das(20), D/O- Gouranga Das of Ashigar, Loknath Mandir, PS- Bhaktinagar, Dist- Jalpaiguri and (6) Pinkey Barman(24), D/O- Raj Kanta Barman of Thakurnagar, BJP Para, PS- Bhaktinagar, Dist- Jalpaiguri, Riya Saha and others arrange for its investigation.
