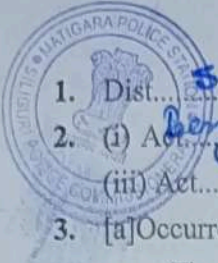

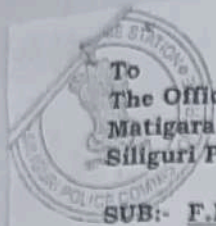

Sir,

In producing herewith one arrested accused person named Sajal Das (32 yrs) S/O Sunil Das of Patiram Jote, Near Matrichhaya, PS- Matigara, Dist.- Darjeeling along with the following articles under proper seizure as per seizure list.

(i) 12 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit, each bottle containing 600 ml and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Sajal Das (32 yrs) S/O Sunil Das of Patiram Jote, Near Matrichhaya, PS- Matigara, Dist.- Darjeeling to the effect that on 23.07.2022 at 22.10 hrs I received a specific source information that one person named Sajal Das of Patiram Jote, Near Matrichhaya, PS- Matigara, Dist.- Darjeeling is selling liquor at his shop at Patiram Jote near Matrichhaya without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 1747 Dated 23.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Patiram Jote, near Matrichhaya to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the shop of above noted accused and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his shop without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Sajal Das (32 yrs) S/O Sunil Das of Patiram Jote, near Matrichhaya, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 23.07.22 in between 22.35 hrs to 22.55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused namely Sajal Das (32 yrs) S/O Sunil Das of Patiram Jote, Near Matrichhaya, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
