Sir,

I Smt. Varinder Devi, d/o Sri Gurdial Singh,wife of Sri. Deepak Chick Bariak, resident of Shivrinar, Saibari, District Darjeeling do hereby lodge this written complaint against the above named persons to the effect that on 23rd day of July 2022 at about 2.00 pm I was informed by my co-villager Sri. Arun Bansfor ,son of late. D. Bansfor that the above named persons along with 30 other miscreants are trying to make an encroachment into my land situated within Mouza-Panchanai,J.L.No.27,Touzi no. 91, Pargana-Patharghata, Police Station –Pradhannagar, District Darjeeling measuring more or less 10 kathas and another land measuring more or less 9.9 decimals which I am purchased vide two Deed of Sales being no. 040300503 for the year 2019, Registered in Book No.I, Volume No.0403-2019. Page from, 10649 to 10672 and another Deed of Sale being No.040301505 for the year 2022 , Registered in Book No. I, Volume No. 0403-2022, Page From 46235 to 46260 both duly registered at the Office of the A.D.S.R, Bagdogra , District Darjeeling vide General Power of Attorney duly registered at the Office of A.D.S.R Siliguri-I , Bagdogra,District Darjeeling in the yersterday 2006. Yesterday on hearing about this ecroachment by the above persons and other Miscreants I rushed to above land with one Smt. Anita Oraon who is also my co-villager and on reaching my land I found that lock of of the iron gate was broken and the above named persons and their associates were inside the iron gate of my land and I saw that they had constructed one temporary structure made of "CHITRA" and bamboos and when I told them that why were they on my land they should and abused me filthy langauge say that the land belong to them and that I have on right title on the said land . I evern tried to make them understand that I hand valid docuements to prove my owneship of the said land but instead of listening to me they started assaulting me with bamboos, fists and blows resulting which I sustained injuries on my person and I was accordingly treated at Sukna BPHC for the injuries and these persons along with above persons eveFn tore my clothes when they assaulted me thus outraging my modesty and there were many persons who are witnes to the this incident but most of them out of fear of these persons are silent over the incident. These persons also snatched my golden chain (Harr) worth 11.140gm and I can even produced the receipt of the same . Thereafter ther local reisdenets of the area came and rescued me from the clutches of this persons who could have even kill me yestereday to fulfill their illegal motive.

Sir, further these persons have threatened me and my family members including my husband with dire consequences say that if we do not hand over the possession to them we will have to bear the consequences for the same.

Sir, I therefore pray that kindly strict legal action may be taken against the above named persons and their associates for assaulting me and outraging my modesty in public yesterday for their illegal gain and also for threatening me and my family with dire consequences.



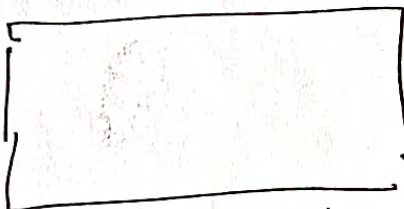
