Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1050 dated 21.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahanto all of NJP PS, SPC left for Micheal Madhusudan Colony, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.40 hrs hrs we arrived at Micheal Madhusudan Colony, and being identified by the source I held raid at the house of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1015 hrs to 1045 hrs.
