In producing herewith one arrested accused person namely Smt. Minati Roy (32yrs), w/o - Tutu Roy of Bogla Mandir, Balarampara, PO- Sahudangi Hat, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

- 1. 16 (sixteen) sealed Bottles of Himalayan Gold 60 Up Country Sprit each bottle containing 600 ML.
- 2. 04 (four) scaled bottles Tuborg Beer each bottle containing 650 ML.

I, ASI. Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 21.07.2022 at 14:35 hrs received a source information from Balaram Para under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE 728, dated 21.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/-625 Bhabendra Das, (2) LC/-1376 Leela Roy (3) LC/-741 Mallika Roy, (4) LCV/-659 Pratima Oraon all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Balaram Para to work out the information. At 14:50hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local stationery shop, situated at Balaram Para main road near Bogla Mandir and recovered the above noted articles from the possession of accused person namely Smt. Minati Roy (32yrs), w/o - Tutu Roy of Bogla Mandir, Balarampara, PO- Sahudangi Hat, PS - NJP, Dist - Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us andstated that she sell the same in the customer since long for her wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Gopal Malakar S/o. Swapan Malakar of Ashighar, PS. Bhaktinagar, Dist-Jalpaiguri after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 15:00 hrs to 15:10 hrs.
