Sir,

In producing herewith one arrested accused person namely Kalo Bala Roy (55yrs), W/o - Anil Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 32 (thirty two) sealed Bottles of Boss 60 Up Country Sprit each bottle containing 600 ML.

I, ASI. Sailendra Singh of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 21.07.2022 at 16:05 hrs received a source information from Sudamganj under Ambari-Falakata Out Post that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE 731, dated 21.07.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C/-230 Subash Ch. Das, (2) C/- 256 Bibhuti Mahato (3) LCV/-859 Jahanara Khatun, (4) LCV/-Sampa Bhowmik all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Sudamganj to work out the information. At 16:10hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of the above noted person and recovered the above noted articles from the possession of accused person namely Smt. Kalo Bala Roy (55yrs), W/o - Anil Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses namely 1) Tarjen Roy S/o. Narma Roy of Ambari -Falakata 9 No. Colony, PO. Kamarvita, PS-NJP Dist- Jalpaiguri and 2) Pranab Chowdhury S/o. Lt. Surat Chowdhury of Do after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 16:25 hrs to 16:35 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued her Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Smt. Kalo Bala Roy (55yrs), W/o - Anil Roy of Sudamganj, PO- Kamarvita, PS - NJP, Dist - Jalpaiguri under proper section of law.
