With due respect, I am producing herewith one arrested accused person namely Ramprasad Das (55) S/O Lt. Chirkut Das of Sahid Colony, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. Total 04 (four) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 2.4 ltrs.)
2. Total 02 (two) bottles of Himalayan Fata Fati 70 UP Country Spirit (each bottle containing 300 ml, Total 0.6 ltrs.)
3. Total 04 (four) bottles of Officer's Choice Whisky (each bottle containing 180 ml, Total 7.2 ltrs.)
4. Total 01 (one) bottle of McDonald's Rum containing 375 ml.
5. Total 03 (three) bottles of McDonald's Rum (each bottle containing 180 ml, Total 5.4 ltrs.)
6. Total 03 (three) bottles of Old Monk Rum (each bottle containing 180 ml, Total 5.4 ltrs.)

I, PSI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 21.07.2022 at 19:55 hrs I received a secret source information that one person namely Ramprasad Das (55) S/O Lt. Chirkut Das of Sahid Colony, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at NJP Bazar area under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1083 dated 21.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Mahato, CV/306 Biswajit Roy and CV/824 Niru Yadav, all of NJP PS, SPC left for NJP Bazar area, PS- NJP to work out the information in hand. At about 20.35 hrs we arrived at NJP Bazar area and being identified by the source I held raid at the shop of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.55 hrs to 21.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ramprasad Das (55) S/O Lt. Chirkut Das of Sahid Colony, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
