I, ASI Rabi Tamang of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 22.07.2022 at 14:25hrs received source information from Kamatpara that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for her wrongful gain. This refers to Ambari Falakata Out Post GDE 772 dated 22.07.22. I informed to O/C Ambari Falakata out post about the information and as per his instruction I along with (1) C-256-Bibhuti Mahato (2) C/230 Subhas Das (3) LCV-225 Sabita Roy, (4) LCV-332-Mina Sarkar all of Ambari-Falakata OP, under NJP PS/SPC proceed to Kamatpara to work out the information. At 15:05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Kamatpara at the house of the above noted accused person and recovered the above noted articles from the possession of accused person namely Satyaboti Roy (48yrs), w/o-Prakash Roy of Kamatpara, PO-Sahudangi Hat, PS-NJP, Dist-Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in the customer since long for her wrongful gain. In presence of witnesses namely 1) Abhijit Majumdar, s/o-Lt. Ashimk Majumdar of Ambari Falakata, PO- Kamarvita, PS-NIP, Dist-Japaiguri and 2) Gopal Malakar S/O Swapan Malakar of Fokdaibari PO Ghogumali, PS. Bhaktinager, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 15:25 hrs to 15:40 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.
