Sir,

In producing herewith the seized articles viz:-

Twelve (12) Bottles of Blu 80 up country Spirit, each bottle containing 600 ML.

seized from the house of Rajokanto Roy (60) yrs S/O Lt Atia Roy of Simulguri P.S NJP Dist Jalpaiguri under proper seizure list in presence of witnesses.

I SI Kamal Sarkar of Milanpally Out Post under NJP Police Station do hereby lodge the written complaint against the accused person namely Rajokanto Roy (60) yrs S/O Lt Atia Roy of Simulguri P.S NJP Dist Jalpaiguri. To the effect that on 23.07.22 at about 14.15 hrs received a secrete source information that the above noted accused person is illegally storing huge number of country spirit in his house for the purpose of selling in open market without any valid license or documents for his wrongful gain. Accordingly I inform the matter to the superior. As per direction of superior I, along with C/-445 Dilip Kumar Roy, C/ 980 Sadhan Barman, VP 12 Dasarathall of Milanpally O.P had been to the Simulguri under Milanpally O.P to work out the information this refers to Milanpally O.P GDE No 623 dated 23.07.22. I, contacted with source and being shown and identified by the source I along with force conducted raid in the house of Rajokanto Roy (60) yrs S/O Lt Atia Roy of Simulguri P.S NJP Dist Jalpaiguri and recovered Twelve (12) Bottles of Blu 80 up country Spirit, each bottle containing 600 ML. The above noted person fled away from his house after seeing the Police team. I managed a independent witness namely 1) Bhabani Roy S/O Karna Roy of Simulguri P.S NJP Dist Jalpaiguri And told him fact of the case. Nobody came that place and nobody produced any valid documents/ License in respect of above noted seized articles. It is crystal clear that the absconding accused person namely of Rajokanto Roy (60) yrs S/O Lt Atia Roy of Simulguri P.S NJP Dist Jalpaiguri is storing and selling the Country Spirit in his house for his wrongful gain.

Accordingly I seized the above noted Country Spirit under proper seizure list in presence of independent witness namely 1) Bhabani Roy S/O Karna Roy of Simulguri P.S NJP Dist Jalpaiguri and 2) Bikash Roy S/O Rajokantao Roy of Simulguri P.S NJP Dist Jalpaiguri under proper seizure list U/S. 102 Cr.P.C. The seizure was made in between 15.05 hrs. to 15.45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be Initiated against the absconded accused person namely Rajokanto Roy (60) yrs S/O Lt Atia Roy of Simulguri P.S NJP Dist Jalpaiguri.
