Sub:- Lodging of FIR for committing criminal trespass, criminal intimidation, attempt to commit extortion and mischief.

Respected Sir,

I, Ashok Kumar Agarwal, S/o Late Jagdish Prasad Agarwal, having address at Life Aid, Second Mile, Sevoke Road, Siliguri -734001, do hereby lodge this written complaint to you informing you that one Parimal Roy, S/o Saral Roy, resident of Chattarapara, Sahudangihat, P.S. Bhaktinagar, Dist. Jalpaiguri, has on 21/07/2022 most illegally and unlawfully trespassed into my landed property as described in the schedule mentioned hereinbelow and attempted to forcibly encroach upon the same by engaging some local hooligans and land mafias inter alia resorting to threats and intimidation. I, upon receiving information from local persons that the above stated Parimal Roy along with his associates have trespassed into my landed property, immediately undertook urgent steps to ensure that my property is not forcibly encroached upon by the said persons.

In this regard it is apt to mention here that I am the absolute owner of the below schedule mentioned land property having purchased the same vide several registered Deeds of Conveyance, and after purchasing the land, the same has remained vacant but the same is under my lawful possession.

The abovenamed Parimal Roy along with his associates, in furtherance of their unlawful agenda, are trying to create forcible obstruction in the carrying out of necessary works upon my landed property and are also threatening to demolish the boundary wall surrounding my landed property, by deploying means of threats and coercion, including but not limited to, making demands for exorbitant sums of money as protection money in lieu of allowing the work to be completed.

The said acts of the abovenamed Parimal Roy and his associates are without any lawful justification and as such they are required to be booked for committing the offence of criminal trespass, criminal intimidation, attempt to commit extortion and mischief. Notwithstanding the above, the said miscreants have also interfered with and are continuously interfering with my lawful right to the peaceful enjoyment of my property.

In view of the circumstances as is complained hereinabove, I humbly request you to direct necessary investigation into the criminal acts of the miscreants namely, Parimal Roy and his associates, and register an FIR against them so that the said criminals may be dealt with in accordance with law without any further delay.
