Sir,

With due respect, I am producing herewith one arrested accused person namely Pawan Sah (29) s/o Subhasg Sah of Jabravita, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 1.12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- 2.01(one) bottle of Royal Stag Blended Whiskey containing 375 ml.
3. 03 (three) bottles of Officer-Choice Deluex Whiskey containing 180 ml in each bottle.

I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 23.07.2022 at 21:10 hrs I received a secret source information that one person namely Pawan Sah (29) s/o Subhasg Sah of Jabravita, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his home at South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1185 dated 22.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahanto all of NJP PS, SPC left for South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 21:25 hrs we arrived at South Shantinagar, Jabravita, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the house of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 21:35 hrs to 21:55 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Pawan Sah (29) s/o Subhasg Sah of Jabravita, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
