**SUB:- Written complaint against SHYAM THAPA and their men and associates.**

Respected Sir,

I, SRI GHANSHYAM AGARWAL, Son of Late Tarachand Agarwal, Resident of Nehru Road, Khalpara, Siliguri, P.O and P.S. – Siliguri District – Darjeeling, PIN-734005, Would like to inform you the acts as stated herein under.

1. That Sri Tarachand , Sri Lakhmichand Agarwal, Sri Narsingh Das Agarwal and Sri Jagdish Prasad Agarwal, All are sons of lake Makhanlal Agarwala were the joint, absolute and exclusive in possession of all that piece or parcel of land measuring 0.25 Acres, comprised in R.S. Plot no. 102 and other plot/s corresponding to L.R. Plot No-440 and 456, recorded in R.S.Khatian no. 33/1, situated within Mouza- Dabgram, J.L. No 2, R.S. Sheet No 2, pargana – Baikunthpur, District – Jalpaiguri by virtue of a deed of conveyance, executed on 10.05.1963, registered in the office of the district sub-Registrar, entered in Book No – 1, Volume No – 51, Pages from 24 to 26, being document no. 4096 for the year 1963.
2. That the above named Sri Tarachand Agarwal died intestate leaving behind him, his only son- Sri Ghanshyam Agarwal as his only legal heir to inherit his share in the aforesaid land.
3. That the above named Sri Lakhmi Chand Agarwal died intestate leaving behind him, his following legal heirs to inherit his share in the aforesaid land:
  - i) Sri Anand Kumar Agarwal
  - ii) Sri Binod Kumar Agarwal
  - iii) Sri Sanjay Kumar Sarsodia
4. That the above named Sri Narsingh Das Agarwal died intestate leaving behind him, his following legal heirs to inherit his share in the aforesaid land:
  - i) Sri Mahendar Kumar Sarsodia
  - ii) Sri Rajendar Sarsodia
  - iii) Sri Suresh Kumar Goyal
5. That the above named Sri Jagdish Prasad Agarwal died intestate leaving behind him, his only son – Sri Nawal Kishore Goyal as his only legal heir to inherit his share in the aforesaid land.



6. That under the above intestate succession , I along with above named Sri Anand Kumar Agarwal, Sri Binod Kumar Agarwal, Sri Sanjay Kumar Sarsodia, Sri Mahendar Kumar Sarsodia, Sri Rajendar Sarsodia , Sri Suresh kumar Goyal and Sri Nawal Kishore Goyal became the joint and collective owners of the aforesaid land measuring 0.25 Acres, having permanent, heritable and transferable right, title and interest therein, and ever since we have been regularly paying the required taxes and reveue to the appropriate authority with regard to the said land.
7. That this is to inform you that some miscreants along with their men and associates under the guidance and backing of local land mafia are trying to encroach upon the said land on basis of muscle power . The said anti social elements have resorted to threaten us and have demanded to handover in their favour the possession of the said land.
8. That this is to apprise you of the fact that such unlawful activities of the local land mafia are gaining pace with every passing day and we have no alternative but to come before you for protection and assistance.
9. That it is pertinent to mention here that the said miscreants have no documents of title to support their claim and such unlawful conduct on their part is completely unwarranted and without sanction.
10. That under the assurances of our Hon'ble Chief Minister to completely remove the land grabbing activity of land mafias, I have come before you with a payer to provide me with adequate relief.
11. Sir, I shall remain grateful if my instant complaint is taken into consideration and necessary action are taken at the earliest.
