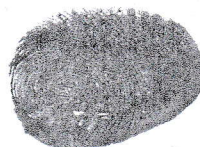
Respected Sir,

I, Kishan Basfore, S/o. Sambhu Basfore, R/o. Near Kedarnath School, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, would like to state that I had some hot verbal talk with Sunny Mahato, S/o. Kameshwar Mahato, R/o. Ho-Chi-Min Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014 on 19-06-2022 at about 8.30 P.M. Suddenly Sunny Mahato started shouting and called his family members and all the family members of Sunny Mahato & Sunny Mahato himself started physically assaulting me. I was mercilessly beaten by (1) Sunny Mahato, (2) Upender Mahato, (3) Mina Devi Mahato, (4) Kameshwar Mahato, (5) Mira Mahato & (6) Basanti Mahato All R/o. Ho-Chi-Min Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014. Due to their assault I sustained injuries in my face & head. Hearing my hue and cry my family members who reside nearby came and saved me from their cruel hands. They all were using slang language and threatened me & my family members who saved me. They even assaulted my family members. Later my family members took me to Bagdogra Hospital for treatment.

It is requested before you to kindly take necessary action against (1) Sunny Mahato, (2) Upender Mahato, (3) Mina Devi Mahato, (4) Kameshwar Mahato, (5) Mira Mahato & (6) Basanti Mahato as per law so that I can get back my hard earned money back.
