I,Hasina Khatun, Wife of Md. Maqsood, resident of Mallaguri, Ratan Lal Basty, Ward No.1 of S.M.C. P.O & P.S. Pradhan Nagar, Dist- Darjeeling, would like to report you the following facts:-

1. That on 23.7.22 at about 8 p.m. when I along with my younger sister Sakina khatoon and my mother Rehana Begam, was at our house at that time 1. Ajhoda Mahato, Son of not known, 2. Manoj Mahato, Son of Ajhoda Mahato, 3. Smt. Saili Devi Mahato, Wife of Ajhoda Mahato, 4. Renu Mahato, 5. Husband of Renu Mahato, 6. Babita Mahato, 7. Rakhi Mahato, 8. Husband of Rakhi Mahato, 9. Wife of Manoj Mahato, all are of same locality near Durgagri, Radha Krishna Mandir, Ward No.45 of S.M.C, raising slogan against Muslim Community forcefully entered into on home and started abusing us and saying bad things about our community and when we protested at that time they started assaulting us by belt, lathi and iron rod and hit us badly and touched our body parts in vary bad way and out raged our modesty and also torn for our wearing apparels they even too in order to cause miscarriage of my younger sister Sakina Khaton hit badly on her stomach by helmat. They were constantly threatening us to leave our area otherwise they would burn down our home. Due to their such assault we all received injuries on our body but my seven months pregnant sister Sakina Khaton and mother received severe injuries on their bodies and they are still admitted in Siliguri S.D. Hospital and their condition is critical. There is even chance of miscarriage of my sister.

Sir, I was busy in the treatment of my mother and sister and there is none else to look after them. So delay is caused in lodging this FIR which may kindly be condoned.

I, therefore, request you to kindly take necessary legal action against the aforesaid culprits.
