Renuka Pradhan and on visiting the place(Uttar palash, Champasari) it is found locked and on enquiring about them with the neighbours, it is learnt that they saw both mother and daughter leaving the place hastily on 26/07/2022(afternoon) with their baggages. I am in strong believe that my son is in contact with them.

I am extremely worried about his safety and maybe he is in danger.

Therefore, I would like to lodge General Diary/FIR in this regard and humbly request you to help me in tracing out my son.
