In producing herewith arrested accused persons manely (i) Shyam Limbu(41yrs) S/o- Lt. Krishna Bahadur Limbu of Jyotinagar Colony, Jail Khana road, W/no- 20, PS- Siliguri, Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: i) 12(Twelve) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan-Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*12-Rs 1440/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest,

I, PSI Sumit Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Shyam Limbu(41yrs) S/o- Lt. Krishna Bahadur Limbu of Jyotinagar Colony, Jail Khana med. W/no- 20. PS- Siliguri, Darjeeling to the effect that on 28.07.22 at 20.15 hrs acting on secret source information that the above noted person was busy to sale ld Liquor illegally at his house situated at Jyotinagar Colony, Jail Khana road, W/no- 20 under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other sofficer and forces left for Jyotinagar, Ward no- 20 under Siliguri PS vide GDE no- 1834 dated 28.07/22. On reaching at 20:25hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as he violated the norms of Bengal Excise Act for selling the said seized Liquor without any valid License. On search i) Twelve (12) sealed bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (amounting of RS 120/- * 12- Rs 1440/-) in which one sealed bottle has taken from mother packet box as sample as per scizure list which was kept concealed in his house under Siliguri PS. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20:45hrs to 21.15 hrs. As such I arrested him U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Shyam Limbu(41yrs) S/o- Lt. Krishna Bahadur Limbu of Jyotmagar Colony, Jail Khana road, W/no- 20, PS- Siliguri, Darjeeling along with seized articles undesproper section of law and arrange for its investigation.
