Respected Sir/ Madam,

This is to inform you the I Smt. Mampi Roy, Wife of Sri. Atanu Sarkar, R/O of Chanapida(D), Duramari (D), P.O Purbaduramari, P.S: Bhaktinagar, Dist: Jalpaiguri, PIN: 735233, aged about 29 years, was legally married to Sri Atanu Sarkar, S/o Mathura Sarkar, R/o of MadhayaChayan Para, Ghogomali, Ward no. 37, Dist: Jalpaiguri on 20/08/2014. It is pertinent to mention that I became acquainted with above-mentioned Sri. Atanu Sarkar shortly before marriage. He concealed many facts about him and manipulated me to get married to him. Also he declined to take me to my matrimonial house after marriage; instead he took me to a rented house where we resided for few months. After which I got pregnant and my mother-in-law namely, Swapna Sarkar came to visit us and I requested her let me live my matrimonial house as I was not keeping well due to my pregnancy. Right after I reached my matrimonial house I noticed sudden and strange in the behavior of my husband and my in-laws. They started torturing me mentally and physically. Also asked me get money from my father every now and then, and if I denied abiding by them they even tried to strangle me and threatened me to kill my child. They also did not let me enter the kitchen and temple owing to my caste and at often times taunted me as I belonged to schedule caste. Also I suffer from a medical condition of Locomotive disorder which requires me to take food and medicine regularly but they did not give me sufficient food to eat and did not provide any treatment or medication for my diseases or pregnancy. Sometimes they physically tortured me by pushing me, hitting me, slapping me etc., without any reason.

I got admitted to a private nursing home for the delivery of my child and a girl child was born on 29th April 2015. After 5 days when I returned back home from the nursing home I noticed that my cupboard was opened and all the jewellery given as stridhan by my parents, that valuation of which

was about 5 lakhs rupees in 2014, was sold without my knowledge and consent by them. Right after my child was born their torture manifold as I had given birth to a girl child. Right after 12 days they told me that they cannot look after my child as I haven't given birth to male child and me and asked me to live with my parents for a while. My husband forcefully sent us to my paternal house. But for 3 years or so they hardly came to visit and sent me no financial aid for me or my child. After which I decided to go back to my matrimonial house. When I reached they disowned me. My father-in-law, namely Sri. Mathura Sarkar told that the child doesn't belong them. Then with the help of the local Councilor and neighbors I went inside the house. They did not let me live with them and separated me from them in a corner of the house. Then that on 2nd May 2020 they threw me out of my matrimonial house along with my child, without any reason.

That recently on 27th of July 2022, at about 3.30 p.m I went to my matrimonial house, but they did not allow me to enter the house instead my husband slapped me hard on my face and pushed me out of their house premises by using filthy, obscene and abusive language. My husband along with my in-laws threatened to kill me and daughter if I enter into their house. I had no other way but to escape from their and left my matrimonial house heavy heartedly.

Therefore it is my earnest request to you to please take appropriate legal actions against the above-mentioned accused persons for the ends of justice.
