In producing herewith one lady arrested accused namely (i) Marzina Khatun (40yrs) W/O- Md. Bappa, of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: i) Ten (10) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ML each labeled as Himalayan Endeavour PVT Ltd Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*10=Rs 1200/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I ASI Siben Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted lady accused namely Marzina Khatun (40yrs) W/O- Md. Bappa, of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling to the effect that on 30/07/22 at 13:15 hrs acting on secret sourcee information that the above noted person was busy to sale Id Liquor illegally at her house situated at Tikiapara, Matangini- II, W/no- 28 under Siliguri PS in order to elandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces and lady forces left for Tikiapara, Matangini- II, W/no-28 under Siliguri PS vide GDE no- 1738 dated 30/07/22. On reaching at 13:25 hrs there and as identified by the sourcee cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted lady tried to escape from the spot but with the help of Lady force I.C 1282 Swastika Sharma we manage to apprehend the above noted lady and on interrogation she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up country Spirit to locality without any valid documents as she violated the norms of Bengal Excise Act for selling the said Liquor without any valid license. On search recovered Ten (10) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ML each labeled as Himalayan Endeavour PVT Ltd Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*10=Rs 1200/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in her house under Siliguri PS. On being interrogation she could not produce any valid documents in respect of said liquor. She also stated that she is doing this Liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 13:45 hrs to 14:15 hrs. As such I arrested her with the help of Lady force I.C 1282 Swastika Sharma U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Marzina Khatun (40yrs) W/O- Md. Bappa, of Tikiapara, Matangini- II, W/no- 28, PS- Siliguri, Dist-Darjeeling along with seized articles under proper section/s of law and arrange for its investigation.
