With due respect and humble submission, in producing herewith one accused namely Biren Sah (52) S/O Lt Sukdeb Sah of Rajendra nagar Coolipara,,P.S- Pradhannagar,Dist.Darjeeling ,P.S- PDN,Dist.Darjeeling under arrest along with following articles under proper seizure ;

- i) 15(Fifteen) Plastic bottles of Himalayan Gold, Country Spirit, 60* up, each bottle containing 600 ML,

I ASI Tarun Kanti Ghosh' of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today i.e on 30.07.22 myself along with force ,CV/223 Swapan Chettri ,Cv/645 Pankaj Gupta all of Pradhannagar PS left for evening Patrolling duty at PS area ,Vide Pradhannagar PS GDE No.1806 dtd.30.07.22 and during patrolling duty at 19.45 hrs I received a source information that one person named Biren Sah was storing and selling liquor illegally in his tea shop in front of Kiran Chandra Sasan Ghat under Pradhannagar PS .Accordingly I share the information with you ,and as per your direction rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop ,recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 20.25 hrs to 21.05 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Biren Sah (52) S/O Lt Sukdeb Sah of Rajendra nagar Coolipara,,P.S- Pradhannagar,Dist.Darjeeling ,P.S- PDN,Dist.Darjeeling and arrange for its investigation.
