SI Rabindra Nath Sarkar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Ashoke Sotang Rai (40) S/O Lt. Purna Bahadur Rai of Prokharabong ,P.S- Sukhia ,Dist.Darjeeling , to the effect that on 31/07/2022 at 18.25 hrs myself along with other officers ASI Biplab Das, ASI Prabal Sarkar, ASI Tarun Kanti Ghosh C/762 Majibar Rahaman ,C/1169 Prasenjit Barman ,C/1413 Sujit Sarkar left from PS for Salbari area for special raid duty vide Pradhannagar PS GDE No.1859 dtd.31.07.22. On way to Salbari I received a source information that one namely Ashoke Rai kept huge numbers of illicit liquor in the restaurant styles as "Horanbil "and selling the same to the customer for their wrongful gain. Accordingly, I informed to you and as per your direction myself along with officer and force held raid at about 19.15 hrs dtd.31.07.22 in the restaurant styles as "Horanbil" at Salbari under Pradhannagar PS and detained one person who shelling the liquor to the customer, on interrogation he disclose his identity noted above, On searching the restaurant recovered i) 16 (Sixteen) bottles of Budweiser ,MAGNUM, Beer each bottle containing 650 ml. manufactured by Celebrity Breweries Pvt.Ltd .,ii) 05(Five) bottles of Carlsberg, Premium Elephant Strong , Beer each bottle containing 650 ml. manufactured by Carlsberg India Pvt.Ltd, On demand he could not produce any valid documents in respect of the said illicit liquor. Accordingly, I seized and label the same in presence of police witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19.35 hrs and 20.05 hrs. On being asked he stated that he kept the same with a view to sell to the customer without any valid documents . As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said illegal beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Ashoke Sotang Rai (40) S/O Lt. Purna Bahadur Rai of Prokharabong ,P.S- Sukhia ,Dist.Darjeeling ,as per proper section of law.
