It has published at their face book page namely HASHTAG, on 22 July 2022 at 23:24 hrs. The I/C Bhaktinagar PS endorsed to me for it's casing an enquiry and take necessary action after due enquiry. Being endorsed by I/C PS that on 31.07.2022 I along with force had been to "HASHTAG" situated at Planet mall Sevoke road, under Bhaktinagar PS, Dist: Jalpaiguri and conducted local enquiry both open and secret during enquiry it could be learnt from the staff of said Pub that the owner and manager of Pub styled as "HASHTAG" used to play the DJ music with the words "Shiva Shiva....Shambhu.....Shankara.....Hara Hara.. in their Bar and had been using in different way which insulted the God/Goddess and sentiment of Hindu for promoting their business by the name of DJ Shanti People. As the owner and manager have been deliberately insulting the Hindu Gods/Goddess by playing the said Mantra in their Bar which was also publicly published in the Social Media FACEBOOK, INSTAGRAM etc. for promoting their business by the name of DJ Shanti People for their wrongful gain.
