As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, all of NJP PS, SPC left for Fulbari Border Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 21:05 hrs we arrived at Fulbari Border Line, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain.
