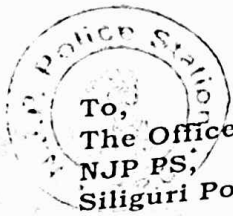

Sir,

With due respect, I am producing herewith one arrested accused person namely Jagadish Roy (51) S/O Lt. Naren Roy of Amaidighi, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml,)
2. 03 (three) bottles of Kingfisher Strong Beer (each bottle containing containing 650 ml) .

I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 30.07.2022 at 20:45 hrs I received a secret source information that one person namely Jagadish Roy (51) S/O Lt. Naren Roy of Amaidighi, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Fulbari Border Line, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1506 dated 30.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, all of NJP PS, SPC left for Fulbari Border Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 21:05 hrs we arrived at Fulbari Border Line, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 21:25 hrs to 21:45 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Jagadish Roy (51) S/O Lt. Naren Roy of Amaidighi, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
