Sub: FIR against the candidates who submitted fake/forged marksheets during the process of engagement of Gramin Dak Sevaks at Department of Posts under Siliguri Sub Division.

In connection to the above mentioned subject and as directed by the competent authority, I, Swastika Chakraborty, in the capacity of the Asstt. Supdt. of Post Offices, Siliguri Sub Division would like to lodge one FIR for the reason that during the online selection/engagement process of Gramin Dak Sevak under the Department of Posts of Siliguri Sub Division and in course of document verification it was found that some of the candidates had submitted fake/forged marksheets/documents. Their marksheets/documents were sent to the concerned boards manually for verification as no result was displayed on online verification and it was established from the verification report that these marksheets/documents were fake/forged.

The details of such candidates who have submitted fake/forged marksheets/documents are as under:

1. Smt. Amar Barman, S/o- Phoni Chandra Barman, Vill-Dolua, PO-Asharu Basti, PS-Chopra, Dist-Uttar Dinajpur-733207 (Mob. No.-9064713937) had initially been selected as Gramin Dak Sevak of Kadamtala Sub Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-7320621) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. मा०शि०प०/ अभिलेख / 25026 dtd. 10.05.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction from Superior Authority the documents were again sent for verification manually from the respective board and thereby it was established that the marksheets/documents presented by him were 'Forged and Fake' as reported vide letter no. मा०शि०प०/क्षे० का०मे०सत्यापन/अभिलेख/837.7 dated 07.07.2022 addressed to the Office of the Postmaster General, North Bengal Region, Siliguri - 734001. Thereafter his provisional candidature was cancelled accordingly.
2. Smt. Bimala Kerketta, W/o- Kishor Tigga, Vill-Chotparua, PO-Karnajora, PS-Raiganj, Dist-Uttar Dinajpur-733130 (Address as per Aadhaar ID-Vill-Bazarugachh, Purba Bansgaon, PO-Chathat, Dist-Darjeeling-734434) (Mob. No.-8637825245) had initially been selected as Gramin Dak Sevak of Gayaganga Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-8795395) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. मा०शि०प०/ अभिलेख / 25022 dtd. 10.05.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction

Thereafter her provisional candidature was cancelled accordingly.

Sri Entaz Alam, S/o- Dabiruddin, Vill-Kalugachh, PO-Bhaispitta, PS-Chopra, Dist-Uttar Dinajpur-733207 (Mob. No.-9775849724) had initially been selected as Gramin Dak Sevak of Rangali Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-7320819) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. ना०शि०प०/ अभिलेख / 24024 dtd. 21.04.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction from Superior Authority the documents were again sent for verification manually from the respective board and thereby it was established that the marksheets/documents presented by him were 'Forged and Fake' as reported vide letter no. ना०शि०प०/क्षे० का०/ने०/सत्यापन/अभिलेख/837.7 dated 07.07.2022 addressed to the Office of the Postmaster General, North Bengal Region, Siliguri – 734001. Thereafter his provisional candidature was cancelled accordingly.

Md. Saha Zamal, S/o- Salimuddin, Vill-Dolua, PO-Asharu Basti, PS-Chopra, Dist-Uttar Dinajpur-733207 (Mob. No.-8392014731) had initially been selected as Gramin Dak Sevak of Haiderpara Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-6789518) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. ना०शि०प०/ अभिलेख / 25026 dtd. 10.05.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction from Superior Authority the documents were again sent for verification manually from the respective board and thereby it was established that the marksheets/documents presented by him were 'Forged and Fake' as reported vide letter no. ना०शि०प०/क्षे० का०/ने०/सत्यापन/अभिलेख/837.7 dated 07.07.2022 addressed to the Office of the Postmaster General, North Bengal Region, Siliguri – 734001. Thereafter his provisional candidature was cancelled accordingly.

Sri Motakabber Ali, S/o- Sariful Islam, Vill-Naya Bari, PO-Asharu Basti, PS-Chopra, Dist-Uttar Dinajpur-733207 (Mob. No.-7501439977) had initially been selected as Gramin Dak Sevak of New Rangia Branch Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-9653819) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. ना०शि०प०/ अभिलेख / 25026 dtd. 10.05.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction from Superior Authority the documents were again sent for verification manually from the respective board and thereby it was established that the marksheets/documents presented by him were 'Forged and Fake' as reported vide letter no. ना०शि०प०/क्षे० का०/ने०/सत्यापन/अभिलेख/837.7 dated

07.07.2022 addressed to the Office of the Postmaster General, North Bengal Region, Siliguri – 734001. Thereafter his provisional candidature was cancelled accordingly.

Sri Rajjak Hussain, S/o- Najrul Islam, Vill-Berjhari, PO-Sujali, PS-Islampur, Dist-Uttar Dinajpur-733207 had initially been selected as Gramin Dak Sevak of Bagdogra Airport Sub Post Office through the online selection process and later submitted the physical copies of the marksheets/documents (Roll no.-7320622) for processing of the recruitment procedure. Accordingly the marksheets/documents were sent to the concerned board, viz., Board of High School and Intermediate Education, U.P.. A verification report vide letter no. मा०शि०प०/ अभिलेख / 24024 dtd. 21.04.2022 was received whereby the documents were reported to be genuine and authentic. Since the issue of submission of fake certificate was highlighted in various newspapers and as per direction from Superior Authority the documents were again sent for verification manually from the respective board and thereby it was established that the marksheets/documents presented by him were 'Forged and Fake' as reported vide letter no. मा०शि०प०/क्ष० का०/मे०/सत्यापन/अभिलेख/837.7 dated 07.07.2022 addressed to the Office of the Postmaster General, North Bengal Region, Siliguri – 734001. Thereafter his provisional candidature was cancelled accordingly.

Hence in the above circumstances and as directed by the competent authority, the undersigned desires to lodge an FIR against the above mentioned individuals/candidates who have submitted fake/forged marksheets/documents and also take necessary action as deemed fit for their involvement in this serious offence of falsification/forgery of documents.

Your kind office is also requested kindly to supply copy of the FIR at the earliest for further course of action.
