In producing herewith the 02 (Two) accused persons namely (i) Raju Banik (41) S/O Lt Basudeb Banik of Udayan Colony, 1 No Dabgram, Ward No-23, PS Siliguri Darjeeling and (ii) Anil Das (40) s/o Lt Hiralal Das of Binay More Dakshin Shanti Nagar, (Near Shanti Sangha Club), Ward No-36, PS Bhakti Nagar, Jalpaiguri alongwith the following seized articles with seizure list;

- (1) Cash Rs. 4185/- as Board money
- (2) 52 Nos of Playing Cards
- (3) One blue colour plastic measuring approx 6 feet X 8 feet
- (4) 2 bottle of country sprit styled as Himalayan Gold

I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar PS SPC do hereby lodged a written complaint against four accused persons namely (i) Raju Banik (41) S/O Lt Basudeb Banik of Udayan Colony, 1 No Dabgram, Ward No-23, PS Siliguri Darjeeling and (ii) Anil Das (40) s/o Lt Hiralal Das of Binay More Madhya Shanti Nagar, (Near Shanti Sangha Club), Ward No-36, PS Bhakti Nagar, Jalpaiguri (Both are arrested) and two others namely (iii) Sumantha Sarkar @ Prashanta (House owner) S/O Sri Mukanda Sarkar of Madhya Shanti Nagar, Lokenath Mandir Road, (Near Lokenath Mandir), PS Bhaktinagar, Jalpaiguri and (iv) Suman Majumdar S/O Ajay Majumdar of Binay More, Madhya Shanti Nagar, PS Bhaktinagar, Jalpaiguri (SI No iii and iv flee away), to the effect that today on 08.08.22 at 14:15 hrs. I received an source information that a gambling is going on inside the house of one Sumantha Sarkar @ Prashanta S/O Sri Mukanda Sarkar of Madhya Shanti Nagar, Lokenath Mandir Road, (Near Lokenath Mandir), PS Bhaktinagar, Jalpaiguri in a tin shed room. Accordingly I informed the matter to O.C Ashighar OP under Bhaktinagar PS SPC and as per his kind direction I diarized the matter vide Ashighar OP G.D.E. No 216 dated 08.08.22 and myself along with ASI Inzamamul Haque, ASI Pralhad Singha, C/877 Munna Ahammed, Const 1013 Sanjay Singha and CV-1016 Amrit Roy all of Ashighar OP left for the spot to verify the veracity of information vide Ashighar OP G.D.E.No 217 dated 08.08.22. On arrival at 14:45 hrs at the spot, found that 04 persons were playing gambling with the help of Playing Cards by cash with a view to wrongful gain and wrongful loss of each others. On seeing the Police party they tried to flee away from the spot but after a hot chase we managed to apprehended two accused persons and the rest two accused persons managed to flee away. On interrogation they disclosed their name and address as (i) Raju Banik S/O Lt Basudeb Banik of Udayan Colony, 1 No Dabgram, Ward No-23, PS Siliguri Darjeeling and (ii) Anil Das s/o Lt Hiralal Das of Binay More Dakshin Shanti Nagar, Ward No-36, PS Bhakti Nagar, Jalpaiguri. On further interrogation they stated that they along with two other accused persons namely (iii) Sumantha Sarkar @ Prashanta (House owner) S/O Sri Mukanda Sarkar of Madhya Shanti Nagar, Lokenath Mandir Road, (Near Lokenath Mandir), PS Bhaktinagar, Jalpaiguri and (iv) Suman Majumdar S/O Ajay Majumdar of Binay More, Madhya Shanti Nagar, PS Bhaktinagar, Jalpaiguri were playing gambling there. But accused Sumantha Sarkar @ Prashanta (House owner) S/O Sri Mukanda Sarkar of Madhya Shanti Nagar, Lokenath Mandir Road, (Near Lokenath Mandir), PS Bhaktinagar, Jalpaiguri and (iv) Suman Majumdar S/O Ajay Majumdar of Binay More, Madhya Shanti Nagar, PS Bhaktinagar, Jalpaiguri were managed to flee away. On being searche on the spot we recovered (i) cash Rs. 4185/- as Board money gambling board (ii) 52 Nos of Playing Cards (iii) One blue colour plastic measuring approx 6 feet X 8 feet and (iv) 2 bottle of country sprit styled as Himalayan Gold which was found lying there. Accordingly I seized all the above noted articles in presence of two independent witnesses namely (i) Ranendra Nath Talukder @ Mastar S/O Lt Debendra Nath Talukdar of South Shanti Nagar, PO- 2 No Dabgram, PS Bhaktinagar Jalpaiguri and (ii) Arun Roy S/o Budhu Roy of do under proper seizure list with a view to take legal action as they violated the prohibition U/S- 3/ 4 of W.B.G. & P.C Act and the above noted arrested two accused persons namely (i) Raju Banik (41) S/O Lt Basudeb Banik of Udayan Colony, 1 No Dabgram, Ward No-23, PS Siliguri Darjeeling and (ii) Anil Das (40) s/o Lt Hiralal Das of Binay More Dakshin Shanti Nagar, (Near Shanti Sangha Club), Ward No-36, PS Bhakti Nagar, Jalpaiguri.

Under the above circumstances it is clear that the above noted accused persons namely (i) Raju Banik (41) S/O Lt Basudeb Banik of Udayan Colony, 1 No Dabgram, Ward No-23, PS Siliguri Darjeeling and (ii) Anil Das (40) s/o Lt Hiralal Das of Binay More Dakshin Shanti Nagar, (Near Shanti Sangha Club), Ward No-36, PS Bhakti Nagar, Jalpaiguri (iii) Sumantha Sarkar @ Prashanta (House owner) S/O Sri Mukanda Sarkar of Madhya Shanti Nagar, Lokenath Mandir Road, (Near Lokenath Mandir), PS Bhaktinagar, Jalpaiguri and (iv) Suman Majumdar S/O Ajay Majumdar of Binay More, Madhya Shanti Nagar, PS Bhaktinagar, Jalpaiguri violated sec - 3 / 4 of W.B G & P.C Act-1957. Accordingly I arrested them as they are violating the above mentioned section of the Acts.

Hence I requested you to start a specific case against the above noted accused persons (i) Raju Banik S/O Lt Basudeb Banik (ii) Anil Das s/o Lt Hiralal Das (iii) Sumantha Sarkar @ Prashanta (House owner) S/O Sri Mukanda Sarkar and (iv) Suman Majumdar S/O Ajay Majumdar and to arrange for its investigation.
