I (Priya Deb , daughter of Late Pranadhan Deb and Smt Reba Deb)am writing this letter to you because I would like to make a formal complaint against my husband. I got married on 30th January 2020 with Mr Sabhasanchi Dutta and Aparna Dutta's only son Mr Vivek Dutta (Bharatnagar , Siliguri) as my husband doing job in Bangalore , we were shifted in Bangalore with my mother in law. From that time period I heard a lot of lies from him and he was also doing mental harassment upon me. Then we were again in Siliguri for durga puja purpose in October 2020. After that we got registry marriage on 7TH JANUARY 2021 from my family pressure because they were not interested in that. In the mean time I got pregnant on 29th june he was born. From this time his mental harassment and lies are getting worst. From the first day of my conceiving time I was at my mother's house. He was unable to take our responsibility (me and my son). Even after my son's birth I wanted to go at my in laws home but they were refusing my words. In the other hand he was charging money from me and my family all the time. He was changing his job one by one and I was totally unaware about this. Then I informed my in laws but they were support their son knowing everything. Even before marriage he was hiding from me about all his house loan, personal loan and other loans including his job. To fulfill their loans my father in law charged money from me also. Day by day his loads of loan is getting in such a worst situation that one of my relative got a message regarding his loan which copy I am enclosing here with this FIR.

Therefore, I am fully determined that I will not stay with my husband and his family. I can't continue this type of relationship because they already ruined my life and now they are trying to ruin my son's life also. Even, when I am informing him about our separation he was threaten me that he will commit suicide and as such it is immensely require to accept my written complaint and take necessary action against the above name alleged person as soon as possible for administration of justice.
