Aktar Ali of Singimari, PO-Singimari, PS- Hatibandha, Dist.- Lal Monir Hat, Bangladesh along with seized article. The ground of arrest has duly been communicated with them.

- One Court Marriage Certificate issued from 1st Class Magistrate, Democratic Government of Bangladesh having Reg No.- 08 date: 07.12.2021 in the name of Kulsum Aktar mani and Md. Abdur Rahim.
- One Noterial Certificate of Religion Change written as Democratic Government of Bangladesh having registration No.- 03 date: 11.11.2021 in the name of Tilak

1 PSI-Pradeep Diylai of New Jalpaiguri PS, Siliguri Police Commissioenrate beg to report before you that on 05.08.2022 at about 08:35 hrs received an specific source information that two Bangladeshi person were residing at rented house at Gorarbari, Nawapara, PS- NJP, Dist.- Jalpaiguri illegally without valid Passport/Visa . Accordingly I informed the matter to SI-Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate as well as Assistant Commissioner of Police, East-II, Siliguri Police Commissionerate and as per their direction of my superior, myself along with ASI Sajal Das, VP/13 Jamirul Islam, C/152 A.K. Mia, LC/1291 Diva Rai, CV/306 Biswajeet Roy all of New Jalpaiguir PS, Siliguri Police Commissionerate left PS to verify the veracity of the information . This refer New Jalpaiguri PS GDE No.- 231 date: 05.08.2022 and MCC No.- 1194/22 date: 05.08.2022. At 0855 hrs Myself along with force arrived at Gorarbari Nawapara, under New Japaiguri PS, as per indication of source held raid at the rented house and being identified by the source we apprehended two accused person including one lady accused. On being asked they gave different statement in different time. After prolonged interrogation they disclosed their name and address as noted above. On further interrogation, they admit their guilt and state that they clope from Bangladesh and entered into India by way of Illegal and they also stated that they are residing here by making forged Indian documents . On being asked they failed to provide any valid Passport/Visa of any other documents in support of entry into India or to reside into India. Subsequently keeping decency Myself with the help of LC/1291 Divya Rai search both the apprehended person including lady and recovered the above noted seized article from their possession. Accordingly I arrested both the apprehended accused person after issuing proper Memo of Arrest and keeping the decency of the women and observing all the guideline issued by the Apex Court. The whole search and seizure was made in between 09:15 hrs to 09:45 hrs.
