I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 06.08.2022 at about 14.25 hrs received source information that one person has gathered huge amount of liquor illegally and selling the same to the local customer at Farabari-Adarshapally for his wrongful gain.
