Sir,

In producing herewith one accused person namely Susanta Sarkar (27 yrs) S/o Sadhan Sarkar of Farabari-Adarshapally, P.O-Sahudangi Hat, Ps-NJP, Dist-Jalpaiguri along with the following seized articles under seizure-

1. 12 (Twelve) Bottles of 60° Up pet Himalayan Gold Country Sprit containing 600 ml. each.
2. One old Nylon bag.

I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 06.08.2022 at about 14.25 hrs received source information that one person has gathered huge amount of liquor illegally and selling the same to the local customer at Farabari-Adarshapally for his wrongful gain. This refers to Ambari Falakata Out Post GDE No. 207 dated 06.08.22. Therefore, I conveyed the same to O/C Ambari Falakata out post and as per his instruction I along with ASI Sailendra Singh, C/975 Swarup Basak & NVF/131 Bidhan Roy, all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Farabari-Adarshapally to work out veracity of the information. At about 15.15 hrs we have reached at Farabari-Adarshapally and searching for the culprit. After few hours I have contacted again with the secret source and being identified by him our police party held raid at Farabari-Adarshapally in presence of two independent witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Biswajit Chanda S/o Lt. Purna Chanda Of Ambari-Falakata 9 No. Colony, P.O-Kamarvita, Ps-NJP, Dist-Jalpaiguri and recovered (i) 12 (Twelve) Bottles of 60° Up pet Himalayan Gold Country Sprit containing 600 ml. each and (ii) One old Nylon bag which is used to store the same, from the possession of accused person namely Susanta Sarkar (27 yrs) S/o Sadhan Sarkar of Farabari-Adarshapally, P.O-Sahudangi Hat, Ps-NJP, Dist-Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same to the local villagers since long for his wrongful gain. Accordingly, I have seized the following articles under proper seizure list in presence of above noted witnesses and took signature of the accused person and witnesses. The seizure was made in between 17.55 hrs and 18.15 hrs. Therefore, I have arrested the said accused u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

Hence, I request you that a specific case may kindly be initiated against the accused person namely Susanta Sarkar (27 yrs) S/o Sadhan Sarkar of Farabari-Adarshapally, P.O-Sahudangi Hat, Ps-NJP, Dist-Jalpaiguri under relevant section of law.
