Sir,

With due respect, I am producing herewith one arrested accused person namely Laxman mahato (40) S/O Lt. Anup Lal Mahato of South Colony, Goyalapatty, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- (i) 10 (ten) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- (ii) 05 (five) bottles of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.
- (iii) 03 (three) bottles of EmBoss whisky containing 750 ML in each Bottle..

I, PSI Pradeep Diyal presently attached with NJP PS under your kind control beg to state that today i.e. on 06.08.2022 at 18.15 hrs I received a secret source information that one person namely Laxman mahato (40) S/O Lt. Anup Lal Mahato of South Colony, Goyalapatty, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his house at South Colony, Goyalapatty under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 307 dated 06.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Kumar Mahato, CV/824 Niru Yadav all of NJP PS, SPC left for South Colony, Goyalapatty, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 18.55 hrs we arrived at Putimari, Dangapara PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the house of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.15 hrs to 19.45 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Laxman mahato (40) S/O Lt. Anup Lal Mahato of South Colony, Goyalapatty, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
