Sub- Written Complaint against Sudip Sutradhar, S/o Lt.  
Chittaranjan Sutradhar of 2/9 Pradhan Nagar, Baghajatin Colony,  
near Baghajatin Sporting Club, Ward No. 2 (SMC), Dist: Darjeeling

Sir,  
Victor Saha, S/o Bhanu Saha of Bagdogra, Ramajote, Bhujiapani,  
P.S. Bagdogra, Dist- Darjeeling would like to draw your kind attention  
to the following effect that I am a driver by profession. My father has  
a court case since very long with Bhagabati Saha. Whereas above  
named person is a brother of said Bhagabati Saha, they all are very  
dangerous by nature and they have no respect towards law and  
justice as because almost 6 months before above named person  
assaulted me at Siliguri Court premises and for which on 28.02.2022  
my mother lodged a written complaint against the said above named  
person but no fruitful result was happened but it is very regret to  
stated that on 6.08.2022 at about 4:14 pm near Air View  
"Poshu Hospital" I reached to drop my passenger at their hotel namely  
"YUMA" at Nabin Sen Road, Mahananda Para, Ward No. 10 (SMC),  
Siliguri. Suddenly said Sudip Sutradhar came from back side and  
without any reason started hit me over my head, shoulder, back with  
his hand and helmet with intention to kill me and also randomly he  
punched over my head for which I get several injuries over my body,  
back and head. I somehow manage to escape with the help of the  
passengers and took shelter at the hotel premises, but said person  
followed me and again started beat me and on that time when I  
started hue and cry the hotel personnel raised objection and with the  
help of them I somehow manage to save myself and on that time above  
named person fled from there but before leaving the premises said  
person threatened me that he is going to kill me and my family and  
also he will broke my vehicle. It is pertinent to mentioned here that  
the whole incident was captured in the CCTV footage of the Hotel  
Yuma as well as the in the CCTV footage of the building in front of the  
Hotel Yuma. After the incident I somehow manage to out from there  
and went to the Siliguri Sadar Hospital as I was in mental trauma and  
physically exhausted with so many physical and mental injuries.

In view of above you are requested to take strict legal action against the said above named Sudip Sutradhar, who is a very dangerous person and he tried to kill me threatened me with dire consequences.
